This is a summary of the annual report for the INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 877 ANNUITY FUND, (Employer Identification No. 04-3228497, Plan No. 001) for the period January 1, 2018 to December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$1,075,944. These expenses included \$94,427 in administrative expenses and \$981,517 in benefits paid to participants and beneficiaries. A total of 406 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$17,274,578 as of December 31, 2018 compared to \$17,843,451 as of January 1, 2018. During the plan year the plan experienced a decrease in its net assets of \$568,873. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$507,071, including employer contributions of \$1,282,282, employee contributions of \$190,491, others contributions of \$207,793, earnings from investments of \$-1,209,495 and other income of \$36,000.

The plan has a contract with Principal Life Insurance Company which allocates funds toward individual policies. The total premiums paid for the plan year ending December 31, 2018 were \$0.

2. Assets held for investment;
3. Insurance information including sales commissions paid by insurance carriers; and
4. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
